This Memorandum of Understanding (MoU) is between Rajiv Gandhi Centre for Aquaculture (RGCA), an R&D arm of the Marine Product Exports Development Authority (MPEDA), Kochi, India, represented by its President RGCA (herein after referred as "MPEDA-RGCA" or "First Institution"), and ______ (Name of the Institution) represented by its _____ (herein after referred as "___" or "Second Institution").

WHEREAS, **MPEDA-RGCA** is a registered Society under the Tamil Nadu Societies Registration, 1975 for the promotion of diversified aquaculture through Research & Development mode through hatcheries and farms. Also supporting the shrimp aquaculture sector by establishing Aquatic Quarantine Facility (AQF), Nucleus Breeding Centre (NBC), Broodstock Multiplication Centre (BMC) and NABL accredited laboratories. Further, this Centre also supporting for Technology Transfer and capacity building on diversified aquaculture species and new technologies in aquaculture.

WHEREAS, (Other Institute profile)

WHEREAS, **MPEDA-RGCA** and ______(Name of the Institution), having mutual interest, agreed to develop and implement an MOU for collaborative research and training programmes and technology transfer with the terms and conditions set forth in the following articles:

ARTICLE I

AREAS OF COLLABORATION

In order to further develop the partnership between MPEDA-RGCA , and(Name of the Institution), both the institutions agreed to conduct research and training activities in either institution with the prior approval of their parent institutions, wherein.
a. Scientific personnel/scientists/Subject Matter Specialists in both institutions may collaborate, jointly supervise, and train students /personnel in either institution.
b. The faculty/scientists/Subject Matter Specialists working at MPEDA-RGCA projects/(Name of the Institution) may be recognised as supervisors/ Joint Supervisor for PG and Ph.D. theses and vice versa as per the concerned University/Institutions intended to do so with the recognized Universities/Institutions.
c. Both institutions shall endeavour to organise joint seminars, colloquiums and other scientific/academic and outreach programs on a cost-sharing basis. Students/Research scholars and faculty working at(Name of the Institution) will be allowed to carry out part of their research work and training in MPEDA-RGCA and vice versa, depending upon specific requirements, which will facilitate academic tourism. A nominal fee will be charged by either of the parties in such association for the services extended.
d. MPEDA-RGCA and(Name of the Institution) shall apply for collaboration projects jointly with National and International funding agencies.
e. Both institutions shall endeavour to exchange relevant information in both academic and administrative matters.
f. Both institutions will agree to facilitate academic tourism on a cost-sharing basis.
g. Both institutions, upon identifying areas of collaboration, shall prepare a work plan clearly defining the roles and responsibilities, funding and costsharing mechanism.
It is understood that the work plan developed and approved in accordance with Article IV hereof will define specific MPEDA-RGCA and (Name of the Institution) Collaborative research projects/training programmes for implementation under this MoII.

1.	MPEDA-RGCA will open its research facilities, hatcheries of diversified aquaculture species, demonstration activities viz., laboratory, equipment, library, etc., to(Name of the Institution) researchers/students in mutually agreed areas for research, internship and apprenticeship at a minimum cost where applicable.		
2.	The openings for internship and apprenticeship will be subject to the guidelines prescribed by MPEDA-RGCA from time to time.		
3.	MPEDA-RGCA will allow(Name of the Institution) scholars/students to experience farm, hatchery, and post-harvest practices at its facilities on a minimum-cost basis where applicable.		
4.	During the implementation of any joint program and when there is a need to use the infrastructure of MPEDA-RGCA like meeting or seminar halls, guest houses and other facilities will be provided by MPEDA-RGCA to(Name of the Institution) if available for use at a minimum cost where applicable.

OWNERSHIP AND PUBLICATION OF RESULTS

- 1. Results of collaborative works/research will be jointly published in the public interest as mutually agreed upon.
- 2. The names of authors and co-authors will depend upon their contribution to the research work or may be decided by mutual consent between the student and Guides/Mentors.
- 3. The collaborating institutions, i.e. ______(Name of the Institution) and MPEDA-RGCA, may ensure that the student submits at least two research papers relating to their Ph. D work before submission of the thesis.
- 4. All the outcomes of the collaborative research work conducted at MPEDA-RGCA and ______(Name of the Institution) including all Intellectual Property Rights (IPRs) shall be jointly owned by both parties. As such they shall be in public domain and shall be available to MPEDA-RGCA and _____(Name of the Institution).

Article-IV

TERMS AND CONDITIONS

This MoU may be further renewed or extended upon mutual agreement between the parties, which shall be made not later than six months prior to the termination date.
