<u>Engagement of Retired Executive Engineer to Oversee Civil, Electrical, and Mechanical Repairs, Maintenance Works, and Procurements for RGCA Aquaculture Projects across India</u>

Scope of the Work:

To ensure the successful execution of the Hatchery Building, farms, and other related constructions, repair, and maintenance works, Electrical and Mechanical Repairs and Maintenance work, Procurement of Electrical / Electronic / Mechanical instruments / Equipments / Machineries above a total value of Rs. 2.50 lakhs for the aquaculture related works.

RGCA is proposed to engage retired and experienced Executive Engineers under various categories as mentioned below: The selected Engineers will provide comprehensive technical expertise and a streamlined approach to project execution. In this regard, the following specialized technical expertise is required and the details are furnished below:

- Technical Evaluation: The Engineer shall scrutinize, evaluate and certify the civil drawings, layout plans, and detailed building designs prepared by RGCA Engineers. The bid / tender documents and BOQ prepared based on the approved designs by the RGCA Engineers/officers has to be vetted by Retired Executive Engineers based on government norms and guidelines before placing it in the Tender Monitoring Committee.
- 2. Cost Estimation (Civil Work): A Comprehensive cost estimate based on the scheduled rate of Delhi / concerned state / PWD for all components, including building materials and steel structures prepared by RGCA Engineers shall be evaluated and certified by the Engineer before publishing in CPP portal.

- External Expert for Bid Evaluation: The selected engineers will serve as committee members and act as External Experts during the evaluation of technical and financial bids. They will also sign the Minutes of Meeting for both technical and financial evaluations.
- 4. **Site inspections, Assessment and Supervision of Civil Work**: During various levels of execution the work, progress and quality will be assessed and address the technical issues if any. Minutes of Meetings conducted in this regard shall be submitted to the Director, RGCA. Additionally a monthly Work Progress Report shall be submitted on or before the 5th of the following month.
- **5. Certification of Bills:** Bills shall be verified and countersigned by the Engineers
- 6. **Work Completion Report:** Upon completion of work, the engineer has to issue the Completion Certificate duly certified by him.

In short, the selected retired officer will act as a 3rd party consultant on all committees, assisting with preparing, evaluating, and signing BOQs for civil, Electrical and Mechanical works of relevant nature. All the procedures will be followed to submit documents to the Tender Monitoring Committee.

Annexure-2: Payment Terms and Methodology

Payment Terms:

Emoluments for the Services:

- a. The contract related to services such as Civil, Electrical, and Mechanical works (including procurement of equipment and machinery) shall be awarded to the selected Retired Executive Engineer on a percentage (%) basis. Payments will be released based on the services rendered.
- b. The quoted rate must be all-inclusive and shall cover consultancy fees, transportation, boarding and lodging, all applicable taxes, and any incidental expenses. These include, but are not limited to, equipment hire, insurance, testing, fabrication, staff/labour charges, and statutory compliance costs for all project locations within Tamil Nadu and Karaikal. No additional charges will be entertained beyond the quoted rate. For project locations outside Tamil Nadu and Karaikal, Travel Allowance (TA) and Daily Allowance (DA) will be provided as per actuals and based on project requirements.
