1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates

(whichever is lower), subject to the maximum of quoted GST %.

3. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

5. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Scope of the Contract:

- a) The current bid is meant for entering into a **RATE CONTRACT**, between R GCA and the successful bidder, for a period of one year for the product(s) r equested.
- b) RGCA has presence in multiple locations across India and the rate contract is intended to have a uniform rate for the product(s) across all RGCA delivery locations, irrespective of individual quantity, within the contract pe riod. Details of delivery location wise product(s) required is provided under the heading "Consignees/Reporting Officer and Quantity" in the bid docume nt. Kindly note that product/ quantity specified is only indicative and not aff irmative.
- c) The successful bidder shall be issued a Letter of Acceptance (LoA) by RGCA. The date of the Letter of Acceptance (LoA) shall be construed as the Contract start date. Upon acceptance of the LoA, the bidder shall be called as supplier for the contract period. Further to the acceptance of LoA, RGCA will issue multiple purchase/ supply orders from time to time, based on its requirement, within the period of rate contract and the supplier shall deliver the product(s) against each purchase/ supply order.
- d) The supplier shall be fully responsible in supplying the product(s), along wit h all accessories (if any), during RGCA working hours, at his cost and respo nsibility, at the respective RGCA delivery location, within the maximum peri od as mentioned in the bid document from the individual purchase/ supply order.

e) RGCA shall pay the supplier, against each purchase/ supply order, as per the applicable terms of payment

2. Price for the goods:

- a) The price/ rate quoted shall be in Indian Rupees only.
- b) The rate quoted shall be uniform, during the contract period, for all RGCA d elivery locations, irrespective of individual purchase/ supply order quantity.
- c) The price quoted shall be firm for the entire period of rate contract and shall not change based on market price fluctuations or Indian Rupee value fluctuations.
- d) The rate quoted for the goods shall be inclusive of all taxes (prevailing on t he date of application), incidentals, hiring of all necessary equipment, trans portation, insurance, testing, fabrication, expenses of staff/labour, statutory compliances, etc., connected with the contract. Nothing other than the quot ed rates shall be entertained under any circumstances.
- e) The bidder should mention the GST rate quoted for the items prescribed by the Central/State Government as on the date of submission of the bid.

b) Non-receipt of EMD for the specified value and/or within the stipulated time , shall render the bid to be considered as non-responsive. RGCA shall not be

responsible for any delay.

- c) Exemptions on EMD, as determined by the Government of India from time t o time, shall be applicable. Bidder claiming exemption shall submit the duly filled declaration in lieu of bid security (as per format provided in Annexure) along with necessary valid supporting documents. Failing which, the bid will be considered as non-responsive.
- d) Bid security to the successful bidder will be refunded without interest, upon receipt of Performance Security or it can be adjusted against performance s ecurity, as the case may be. Bid securities of the unsuccessful bidders will be refunded without interest, latest by the 30th day after the award of the contract or immediately after the expiry of stipulated bid validity period, which hever is earlier.
- e) A bidder's bid security will be forfeited, without any notice, if the bidder:
 - (i) withdraws or amends its/ his tender/bid;
 - (ii) impairs or derogates from the tender in any respect within the period of validity of the tender/b id;
 - (iii) if the bidder does not accept the correction of his bid price during evaluation; and
 - (iv) if the successful bidder fails to sign the contract or furnish the required performance security within the specified period.
- f) In case of forfeiture of the EMD, the bidder shall become ineligible to partici pate in the re-tendering process, if any.

4. Performance Guarantee/ Performance Security:
