1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which

no purchase preference shall be granted. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the

screenshot of GST portal confirming payment of GST.

4. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

5. Buyer Added Bid Specific ATC

1. Scope of the Contract:

- a. The current bid is meant for entering into a RATE CONTRACT, between RGCA and the successful bidder, for a period of one year for the product(s) requested.
- b. RGCA has presence in multiple locations across India and the rate contract is inten ded to have a uniform rate for the product(s) across all RGCA delivery locations, irr espective of individual quantity, within the contract period. Details of delivery locati on wise product(s) required is provided under the heading "Consignees/Reporting Officer and Quantity" in the bid document. Kindly note that product/ quantity specified is only indicative and not affirmative.
- c. The successful bidder shall be issued aLetter of Acceptance (LoA) by RGCA. The dat e of the Letter of Acceptance (LoA) shall be construed as the Contract start date. U pon acceptance of the LoA, the bidder shall be called as supplier for the contract pe riod. Further to the acceptance of LoA, RGCA will issue multiple purchase/ supply or ders from time to time, based on its requirement, within the period of rate contract and the supplier shall deliver the product(s) against each purchase/ supply order.
- d. The supplier shall be fully responsible in supplying the product(s), along with all acce ssories (if any), during RGCA working hours, at his cost and responsibility, at the re spective RGCA delivery location, within the maximum period as mentioned in the bi d document from the individual purchase/ supply order.
- e. RGCA shall pay the supplier, against each purchase/ supply order, as per the applica ble terms of payment

2. Bid Submission

Eligible bidders may submit their Electronic bid (otherwise called as e-bid or e-tend er) through the GeM Portal (https://gem.gov.in/) on or before the last date of submission. No other mode for bid submission will be considered.

3. Price for the goods:

- a. The price/ rate quoted shall be in Indian Rupees only.
- b. The rate quoted shall be uniform (all inclusive), during the contract period, for all R GCA delivery locations (as mentioned under the head 'Consignees/Reporting Office r and Quantity') irrespective of individual purchase/ supply order quantity.
- c. The price quoted shall be firm for the entire period of rate contract and shall not c

hange based on market price fluctuations or Indian Rupee value fluctuations.

- d. The rate quoted for the goods shall be inclusive of all taxes (prevailing on the date of application), incidentals, hiring of all necessary equipment, transportation, insur ance, testing, fabrication, expenses of staff/labour, statutory compliances, etc., co nnected with the contract. Nothing other than the quoted rates shall be entertaine d under any circumstances.
- e. The bidder should mention the GST rate quoted for the items prescribed by the Ce ntral/State Government as on the date of submission of the bid.

4. Delivery and Acceptance:

- a. Supplier shall deliver the material(s) at the delivery location specified in the respect ive purchase/ supply order, during RGCA working hours, at his responsibility and c ost. Material(s) should be supplied against Tax invoice, e-way bill and other supporting documents.
- b. The material(s) supplied shall be inspected by the RGCA official, who shall certify fo r acceptance of the goods. Only the goods certified by the RGCA official will be con sidered as accepted by RGCA. Goods not accepted by RGCA official should be repl aced by the supplier at his cost and responsibility at the earliest.
- c. The material(s) not accepted by RGCA official shall be taken over by the supplier at his cost and responsibility. If the supplier fails to take back the not accepted material within 15 days of communication by writing/email, then RGCA may dispose-off the material at the cost and responsibility of the supplier.
- d. Liquidated damages for delay in delivery shall be applicable as defined in the General Terms and Conditions on GeM.

5. Payment Terms:

- a. Bill/invoice, along with the supporting documents (if any), duly certified by the RG CA official shall be submitted by the supplier at RGCA office put up at the delivery I ocation, for processing the payment.
- b. Bill/ Invoice shall be processed only for the material(s) accepted by the RGCA official.
- c. All payments are subject to deductions as per applicable laws prevailing in India fr om time to time.
- d. All payments shall be done to the bank account of the supplier.
- e. Interim payment or advance will not be provided. Hence supplier shall ensure avail

ability of adequate money for supply of goods at delivery location.

6. Earnest Money Deposit (EMD):

 - (i) Withdraws or amends its/ his tender/bid;
- (ii) Impairs or derogates from the tender in any respectwithin the period of validity of the tender/bid:
 - (iii) If the bidder does not accept the correction of his bid price during evaluation; and
- iv) If the successful bidder fails to sign the contract or furnish the required performance security within the specified period.
